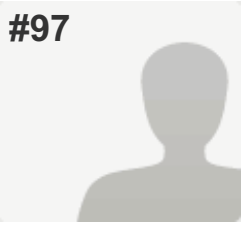

<p>Problem for Edinburgh residents is not so much the calculation of the contribution, as the things it is spent on (tram deficit; statutory notice debacle).</p>
<p><b>Q11: REFORM OF LOCAL TAXATION: Are there alternatives to the current system of council tax that you think would help to reform local taxation in Scotland? What are the main features of these, and why do you think they would deliver improvement? Do you have any examples of why this is the case?</b></p>
<p>Feel very resistant to contributing MORE to Edinburgh's coffers (eg via local income tax) because I simply do not agree with the spending decisions they make, or feel that they can be trusted with the monies they collect.</p>
<p>In an ideal world, Council Tax would be used to pay for rubbish collection and street cleansing, libraries and leisure centres, road and pavement maintenance and other basic services like that (rather than transport vanity projects, enquiries into Council scandals etc). The cost of providing such services correlates reasonably well with a per capita basis, although I understand that people's ability to pay varies a lot. However, I do feel that it is inappropriate to move ever further away from a per capita basis of charge towards a local income tax system. We already HAVE income tax to pay for hospitals, defence, transport etc, why should higher earners also pay double to have their bins emptied?</p>
<p>I might feel differently about the prospect of paying higher local taxation if the monies I already paid were managed adequately.</p>
<p>Edinburgh manages to make no money from the Festival while lining the pockets of hoteliers and a few favoured 'cultural providers'; manages to flog off a priceless asset (RHS) for almost no money; never passes up an opportunity to give the family silver away for free. And then whines that Council Tax for residents is capped - thank goodness it IS or they would bankrupt us all too!!</p>
